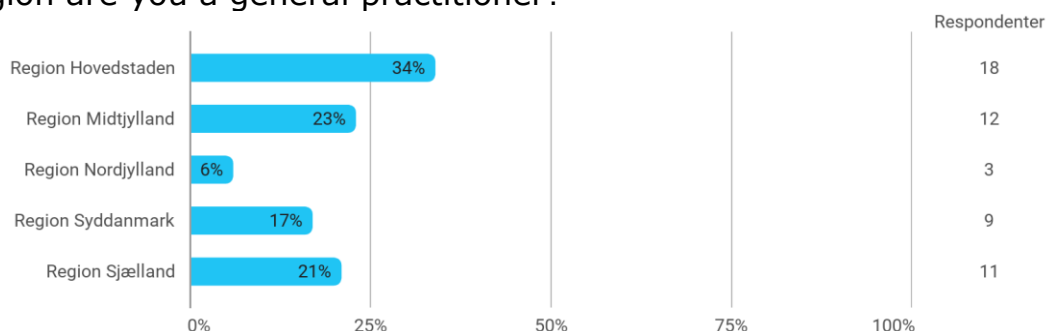


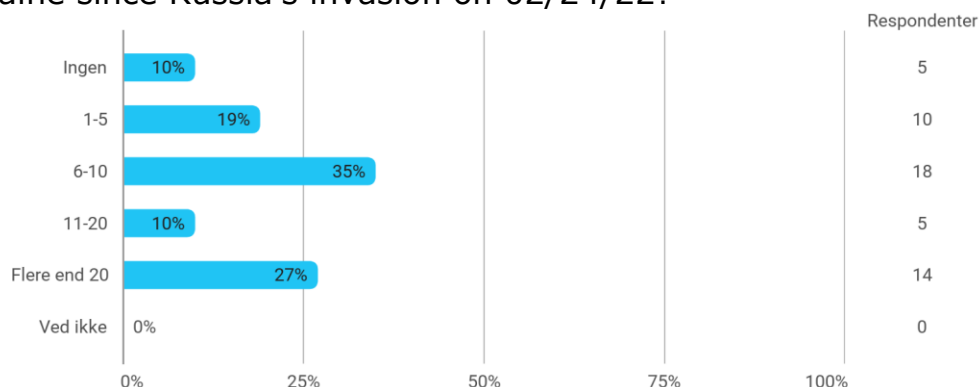

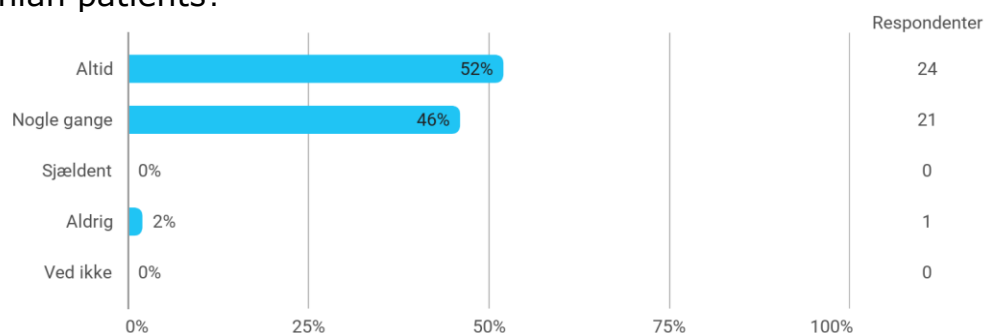
1. In which region are you a general practitioner?



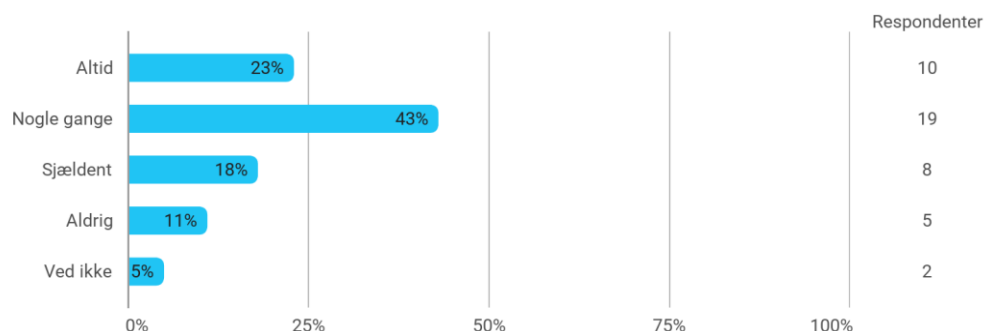
2. How many patients have you met in your medical practice who have been displaced from Ukraine since Russia's invasion on 02/24/22?



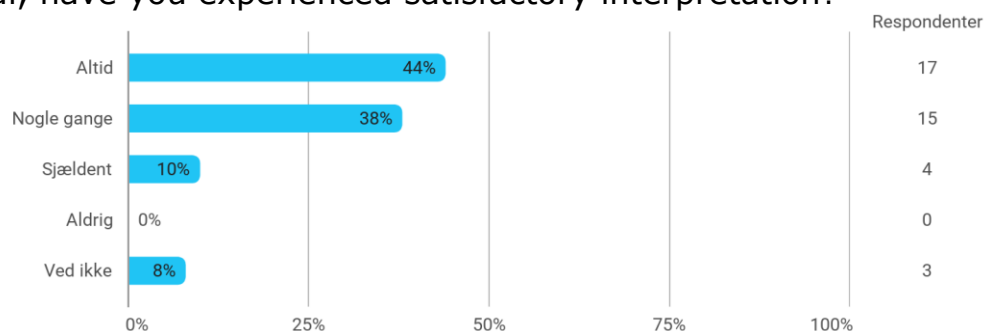
3. Has there been a need for help with interpretation in connection with the treatment of Ukrainian patients?



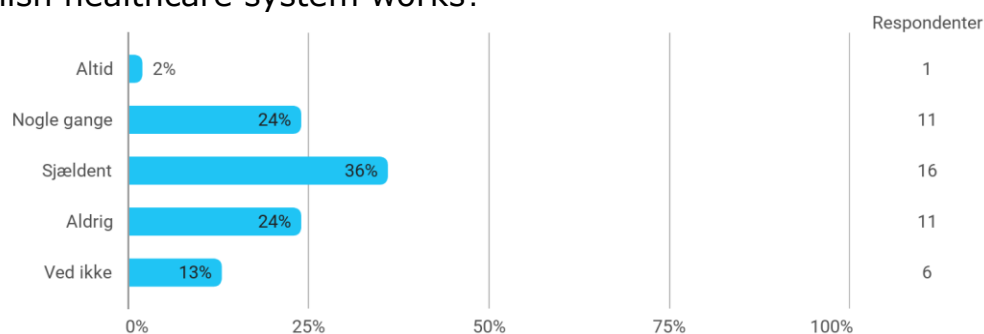
4. When interpretation has been needed, have you been able to get an interpreter?



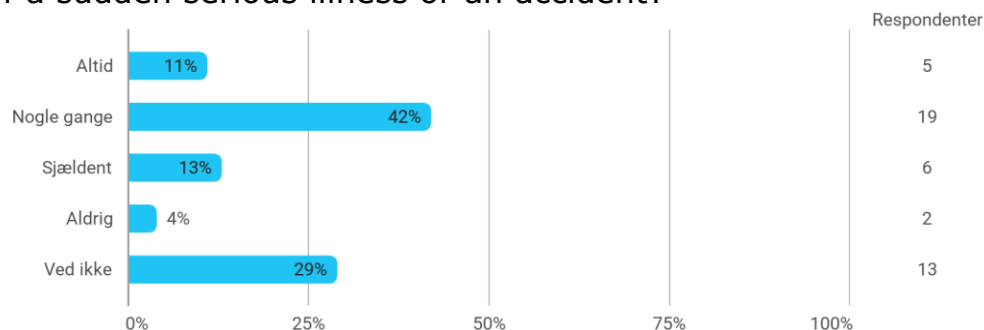

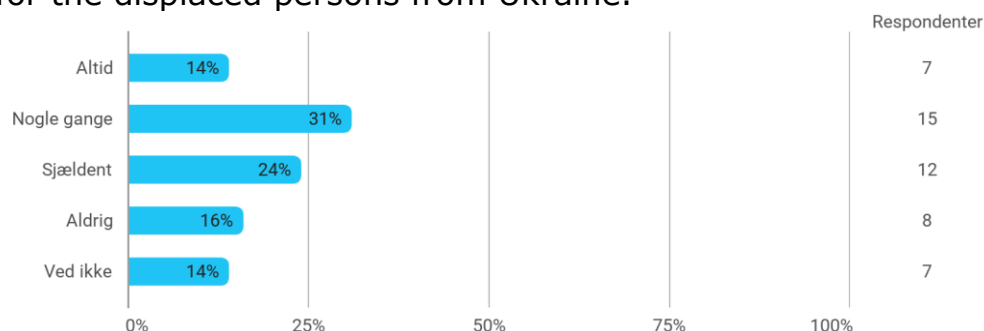

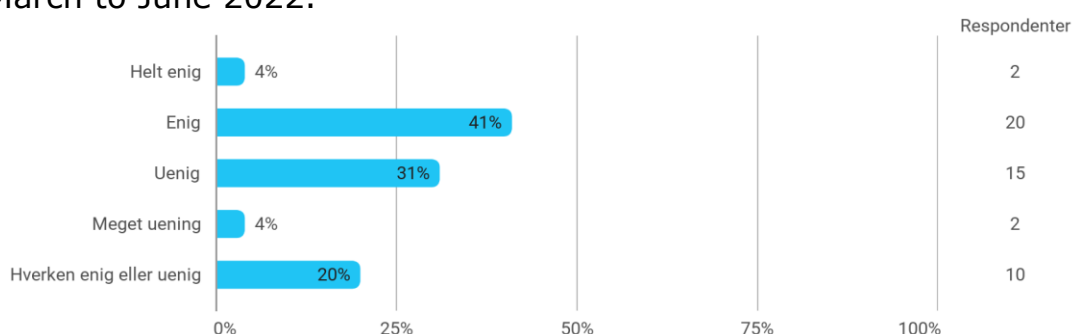

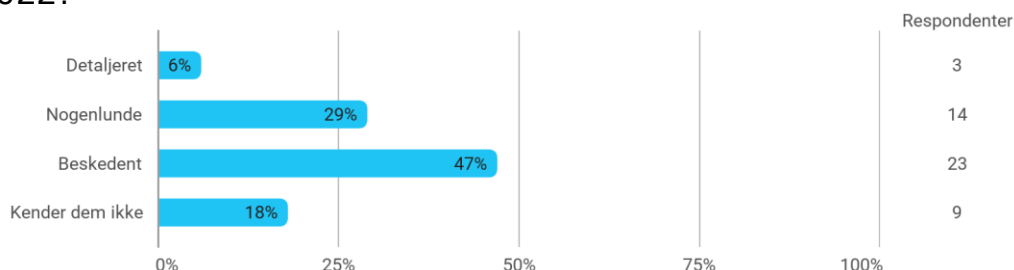

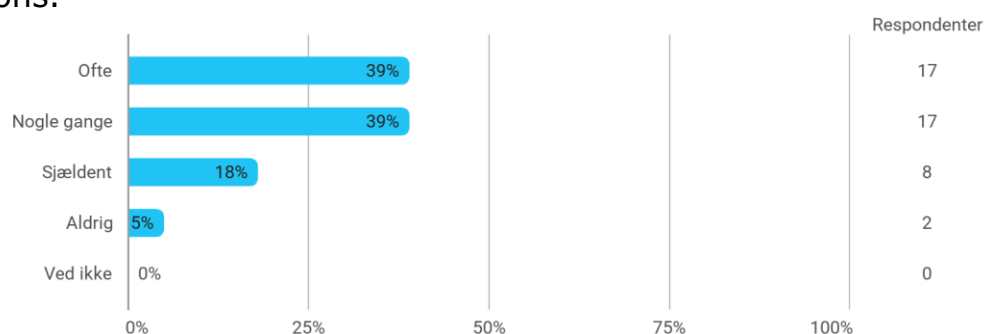

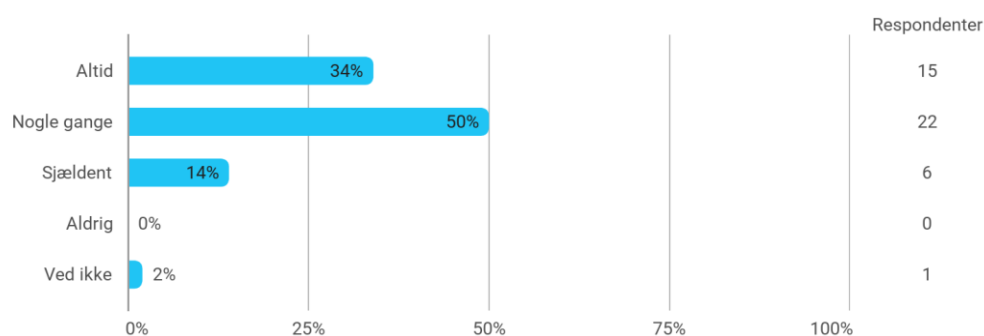

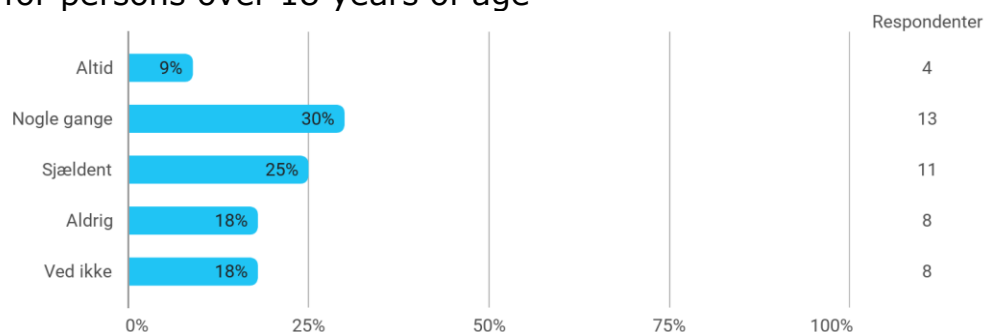

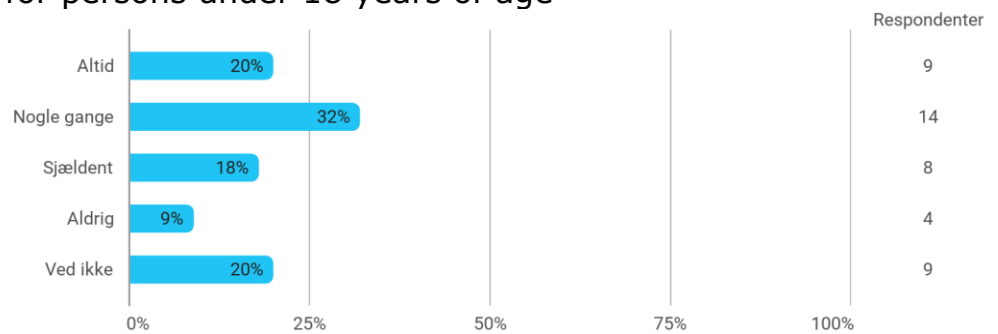

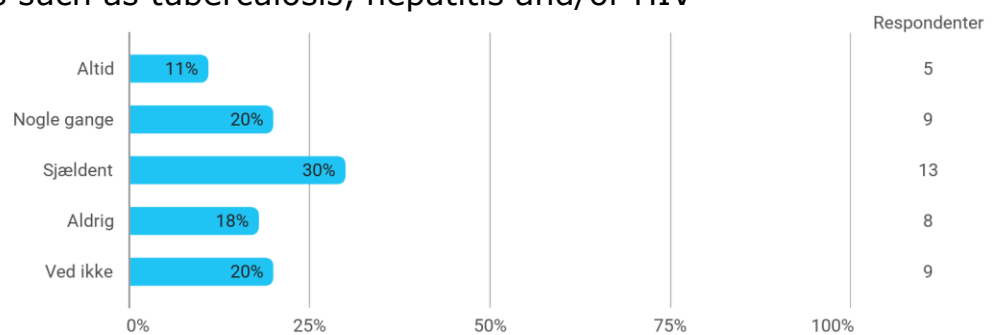

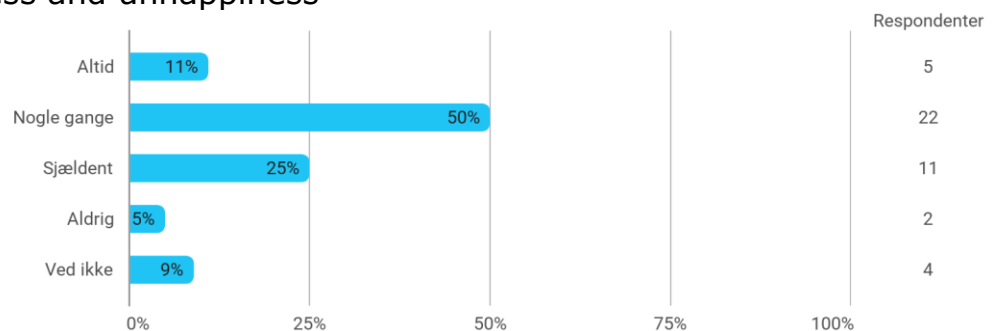

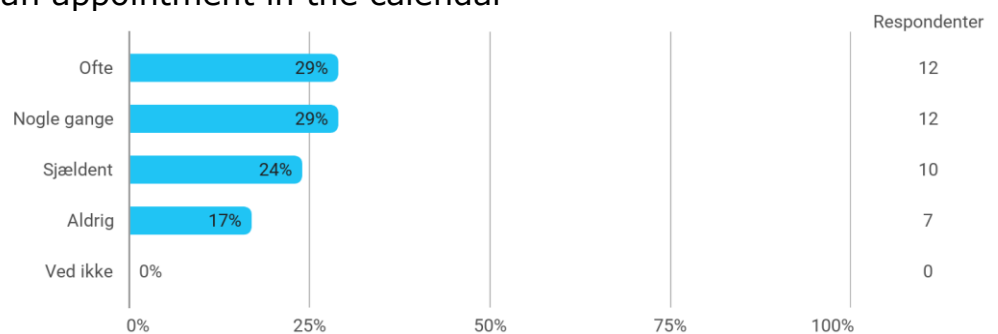

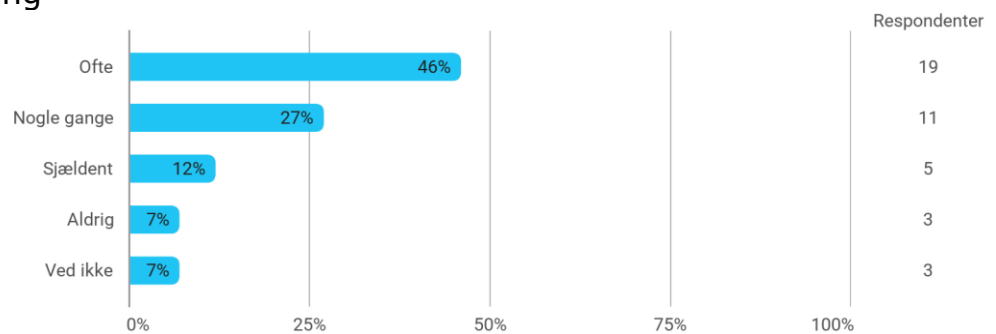

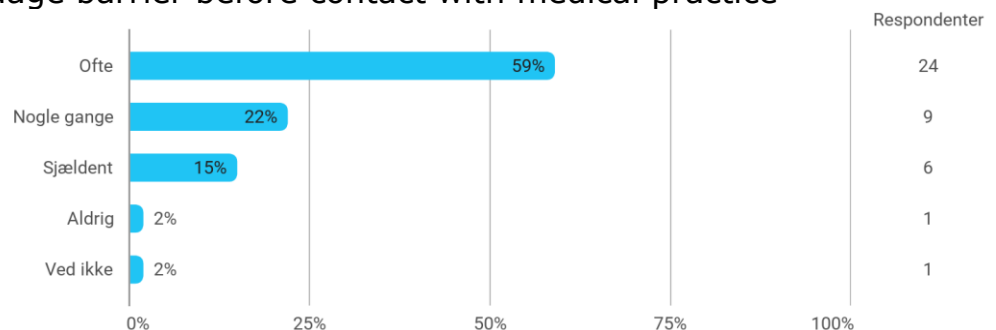

turned up without an appointment in the calendar



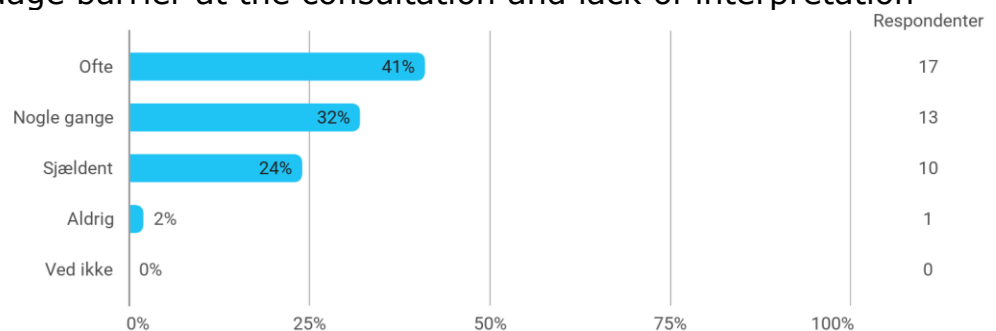
15(b). What has prevented you from being able to ask the necessary questions? - Patients find it difficult to use our access via telephone or online appointment booking



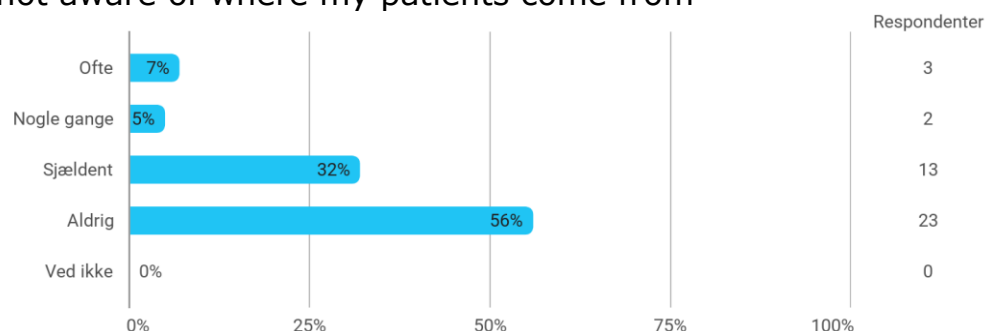
15(c). What has prevented you from being able to ask the necessary questions? - Language barrier before contact with medical practice



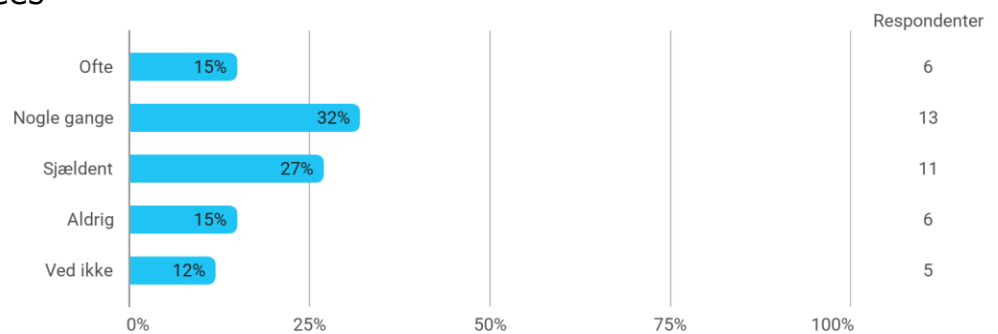

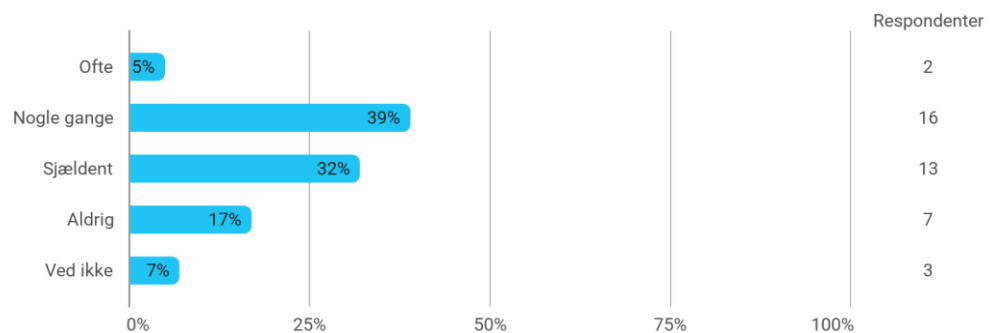

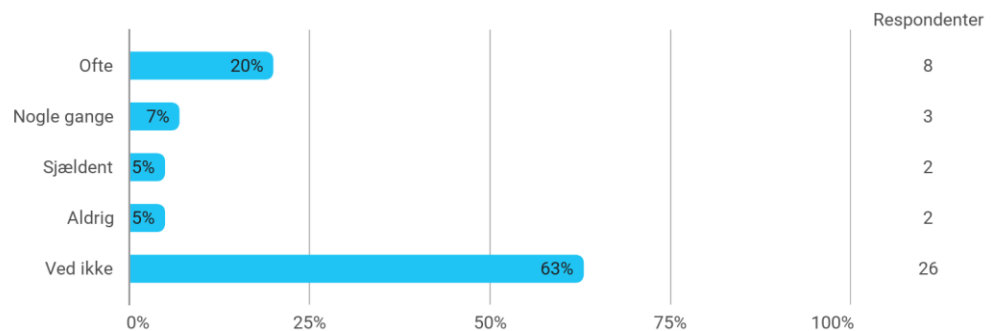

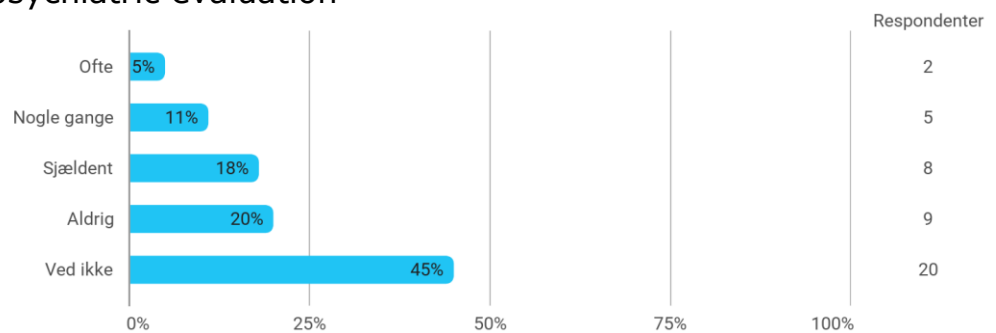

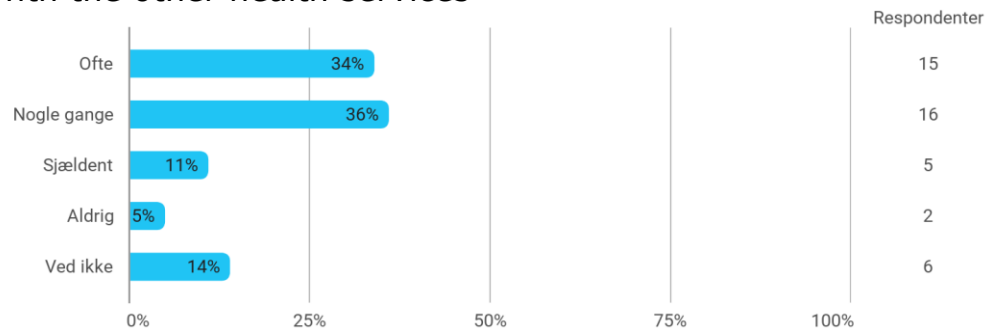
16 (b). How do you experience the following? - In the case of signs of mental stress after war trauma, there has been an offer to refer to
